No. GAG(A) 59/2012/40 : The Governor of Assam is pleased to the relaxation of upper age limit for the retired Commissioned Defence Service Officers on contractual appointment in the Sainik Board Organisation upto 63 yrs of age in place of the existing 60 yrs of age subject to the fulfillment of the condition that the Officer/ Officials appointed should have clean service records and satisfactory performance report. The Officer would be on a fixed Salary of which 75% is shared by the Central Government and 25% of the share will be borne by State Government.

This will come into force with immediate effect.
