OFFICE MEMORANDUM

In partial modification of the OM No.FMP.13/85/104, Dated 29-07-2006 the Governor of Assam is pleased to enhance the amount of ex-gratia grants to the NOKs of State Government employees, Home Guards, personnel of Army and Central Para Military Forces (CPMF) engaged in counter-insurgency operation in the State who are killed in action to Rs. 20.00 Lakhs.

2. The Governor of Assam is also pleased to order that an additional ex-gratia of Rs. 5.00 Lakhs may be awarded in respect of gallantry award winners and Rs. 3.00 Lakhs in respect of the President's Distinguished Service Medal winners.

3. The ex-gratia grants so granted may be apportioned in the ratio of 3:1 between the spouse and the parents of the deceased if the former is without any child. In case the deceased had minor children the grant may be apportioned among the spouse of the deceased, his/her children and his/her parents in the ration of 2:1:1. This share of the children may be fix deposited in a Nationalised Bank for use in their studies in future.
